A. **Regrettably there are no returns or credits for custom or special ordered products.** Products held for more than 7 days after notification of arrival will be automatically charged to the customer's card. The product will be held for an additional 30 days, after which it will be discarded.

B. There are occasions when certain specified lengths cannot be met due to either type of wood or lengths available in the market, and WMM will substitute lengths where necessary. Quantities shipped may vary, within a reasonable amount, from quantities ordered. WMM will invoice at actual quantities shipped.

C. All products must be inspected prior to installation. While we strive for excellence in shipping, occasionally errors may occur. In the event of a discrepancy in quality, quantity or profile, notice must be given to Westcoast Moulding & Millwork Limited (WMM) as soon as possible and no later than 5 days after the arrival of the product.

D. **LIMITED WARRANTY:** A manufacturer's warranty applies to most products sold. This warranty may vary from product to product. In no event shall WMM be liable for any special, incidental, exemplary, or consequential damages, or commercial loss of any kind (including loss of income or profits). WMM's entire liability for breach of warranty is limited to the replacement of defective products, or to an amount not to exceed the price of the defective products. This agreement excludes all implied warranties including, but not limited to, the warranties of merchantability and fitness for a particular use.
